4. First-aid measures

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON Inhalation CENTER or doctor/physician if you feel unwell.

6. Accidental release measures

Personal precautions. protective equipment and emergency procedures

Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Do not breathe mist or vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. Methods and materials for containment and cleaning up
