Transfer by mechanical means such as vacuum truck to a salvage tank or other suitable container for recovery or safe disposal. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material.
