## 4. First-aid measures

**Inhalation** Move to fresh air. Call a physician if symptoms develop or persist.

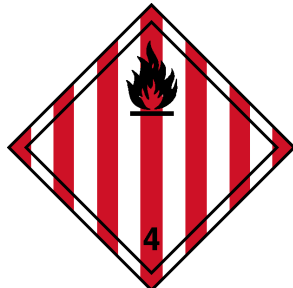
