### 4. First-aid measures

## 7. Handling and storage

### Precautions for safe handling

Store locked up. Store in original tightly closed container. Store away from incompatible materials (see Section 10 of the SDS). Keep container tightly closed in a dry and well-ventilated place. Light sensitive. Store under an inert atmosphere. Air sensitive. Handle and store under inert gas.
