4. First-aid measures

7. Handling and storage

Precautions for safe handling

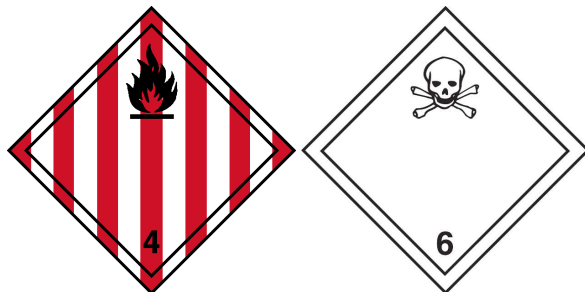
