## 4. First-aid measures

# 5. Fire-fighting measures

## 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. # Methods and materials for containment and cleaning up
