4. First-aid measures

General information

5. Fire-fighting measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. Keep people away from and upwind of spill/leak.
